Douglas County is known for its water. It contains **4 major watersheds**, which drain to the Mississippi and Minnesota Rivers, and contains over **200 lakes**.

Clean water is vital to the health of our community:

- We depend on high-quality groundwater for our drinking water.
- We enjoy our lakes and streams for boating, fishing, and swimming.
- We appreciate our lakes, streams, and wetlands for providing critical wildlife habitat and wildlife viewing.
- We value our local water resources as an economic driver, providing direct and indirect business opportunities.

It is important to **keep our water clean** for our permanent and seasonal **residents**, annual tourists, and future generations.

Our water quality in Douglas County cannot be taken for granted.

- All of our major watersheds have impaired stream/river reaches.
- We have lakes listed as impaired, as well as lakes with declining water quality trends, and lakes considered by the MN DNR as high quality, unimpaired lakes that are at significant risk of becoming impaired.
- Groundwater (i.e. drinking water)
 recharge rates have decreased
 due to the amount of impervious
 surface and high water use. Large
 areas of Douglas County are
 classified as sensitive to
 groundwater contamination from
 surface activities.

- This Component Fund would provide a sustainable source of funding to restore and keep our waters healthy for generations to come.



- Projects that rank the highest for costeffectiveness and multiple benefits will be prioritized and targeted.
- Projects with multiple benefits include those that provide benefits to habitat, surface and groundwater quality and quantity, and flooding and erosion control.
- Projects may include wetland and shoreline restoration, storm water management, erosion control, and protection of high-quality properties.
- Projects will minimize adverse impacts on the natural environment, address existing cultural resources, and result in water quality net gain.
